The Belgian Centre of Expertise for Finance Professionals (ABAF/BVFA) has rewarded Shurgard with this year's Award for Best Financial Communication. Finally, Shurgard's Investor Relations team received the maximum score for its availability and responsiveness, ad hoc press releases, and the availability of detailed consensus figures from analysts, accessible on the website.

This year marks the 63rd presentation of the award.
