

## Oxurion Provides Further Details Concerning the Second Amendment to Negma Funding Program

**Leuven, BELGIUM, Boston, MA, US – January 26, 2023 8:00 am CET** – Oxurion NV (Euronext Brussels: OXUR) a biopharmaceutical company developing next generation standard of care ophthalmic therapies, with clinical stage assets in vascular retinal disorders, has entered into an amendment of its mandatory convertible bonds issuance and subscription agreement with the Negma Group on January 25, 2023 ("funding program").

The amendment provides Oxurion access to four million euros in three tranches with a reduced cool down period of fifteen trading days (instead of twenty-two trading days), provided the terms and conditions of the agreement and the bonds are met. Similar to Part B of the funding program, there is no liquidity requirement and the conversion price of the shares is eighty percent of the lowest closing VWAP over the fifteen consecutive trading days in advance of the conversion notice.

Oxurion (Euronext Brussels: OXUR) is a biopharmaceutical company developing next generation standard of care ophthalmic therapies, which are designed to improve and better preserve vision in patients with retinal disorders including diabetic macular edema (DME), the leading cause of vision loss in working-age people, as well as other conditions. Oxurion intends to play an important role in the treatment of retinal disorders, including the successful development of THR-149, its novel therapeutic for the treatment of DME. THR-149 is a potent plasma kallikrein inhibitor being developed as a potential new standard of care for the up to fifty percent of DME patients showing suboptimal response to anti-VEGF therapy.
