SUEZ ENVIRONNEMENT AWARDED 130 MILLION EURO CONTRACT FOR THE MANAGEMENT OF RESIDUAL HOUSEHOLD WASTE BY DURHAM COUNTY COUNCIL IN THE UK

SITA UK, a subsidiary of SUEZ ENVIRONNEMENT, has been awarded an eight year contract by Durham County Council worth over 130 million Euros¹ to manage 140,000 tonnes of residual household waste each year.

Under the new contract, which will start in June 2013, waste will be put to good use at SITA UK's new energy-from-waste facility in Teesside, which is currently under construction. The residual waste, which is currently landfilled, will generate enough electricity to power 17,000 homes (10 MW).

Jean-Louis Chaussade, Chief Executive Officer at SUEZ ENVIRONNEMENT, declared: "We are very pleased to have been appointed to work with Durham County Council to help put their residual waste to good use. This contract illustrates SITA UK's ability to advise and to provide innovative solutions enabling its customers to reduce their impact on the environment. By recovering energy from residual waste, this project fits well with the government's aspiration to reduce the amount of residual waste that is landfilled."

Don Mclure, Corporate Director, Resources at Durham County Council, said: "We are delighted to be working with SITA UK, whose innovative treatment processes will help ensure the amount of County Durham's rubbish that gets buried in the ground is kept to an absolute minimum. The Council has a target of diverting 75 per cent of household waste away from landfill by 2020 and the new contract will ensure this target will be met and exceeded, with around 90 per cent of waste diverted as the contract progresses."

This contract consolidates SITA UK's position for municipal residual waste treatment within the north east of England, where the company is currently investing in modern waste management facilities. SITA UK provides recycling and waste management services for the South Tyne and Wear Waste Management partnership, Northumberland County Council and a number of local authorities in the Tees Valley.
